## **GUIDELINES AND INSTRUCTIONS**

Nominations to the San Antonio ISD Athletic Hall of Fame are received on a rolling basis, but must be received by the SAISD Athletics Office no later than May 15<sup>th</sup> for consideration in the following year's class. The complete nomination form and support materials should be sent to:

Nomination forms must either be sent by mail or hand-delivered complete with all requested information.

The nomination form must include the following:

- 1) The nomination form itself, completed in its entirety. It is preferable that the nomination form be typewritten. The form is available on the SAISD Athletics Department web site as a PDF document and can be emailed in another format if needed (request additional formats at <a href="mailto:info@saisdfoundation.com">info@saisdfoundation.com</a>).
- 2) Letters of recommendation should be limited to one typewritten page each.
- 3) Photocopies (8.5"x11" letter size) of not more than two of the following: newspaper clippings, magazine articles, event programs, scorebook pages, statistical printouts, or other such materials that substantiate the nominee's accomplishments and contributions. DO NOT SEND ORIGINALS. All information submitted will be retained by the SAISD Athletics Department and the SAISD Foundation.

Once Nominations are screened for eligibility, nominees or next of kin will be sent an Athletic Hall of Fame Application. Those applications are reviewed by the Hall of Fame Selection Committee. Individuals selected for induction as a member of the upcoming class, as well as the individuals nominating them, will be notified in writing of their induction. If an applicant is not selected, the application is placed in the "Hold for Future Consideration" category and automatically resubmitted to the Hall of Fame Selection Committee the following year.

## STATEMENT OF PURPOSE

The San Antonio ISD School Athletic Hall of Fame was founded in 2014 to recognize and preserve the heritage of high school athletics in San Antonio ISD, to keep alive their tradition and spirit, and to honor each year those persons who through distinguished achievement have excelled in one or more high school athletic program.

Hall of Fame nominees shall include individuals who have raised the level of awareness in high school athletics through their distinguished achievement and excellence in one or more high school athletic programs sponsored by SAISD; or through their contributions to high school athletics in other fields of work. These individuals may include student-athletes, coaches, administrators, contest officials, media personnel, sports medicine personnel, athletic trainers, or distinguished volunteers. Nominees may be retired from their field, or still active. Nominees must exemplify the highest standards of sportsmanship, ethical conduct and moral character.

The categories of student-athlete, coach, administrator, and contributor are included on the nomination form for expediency in understanding the primary area in which an individual is to be considered for his or her achievements in high school athletics. These groupings are for screening purposes only and to assist those in making the nominations in understanding the type of information required. Once nominees are inducted, they are not categorized, but all are recognized as members of the SAISD Hall of Fame. To further explain:

- A student-athlete is a former student participant who is being nominated for his or her achievements in high school athletics. To be eligible for nomination, a student-athlete must have graduated from a San Antonio ISD high school 15 or more years ago. Student-athletes will be considered primarily for their achievements as a high school student-athlete. Limited consideration will be given to their achievements on the college or professional levels. Character during and after their high school years, however, will be a major consideration. Candidate must not be a member of the Selection Committee when considered for induction into the Hall of Fame and must be free of felony violations of the law. Nominees will be considered posthumously.
- An **administrator** will be considered primarily on the merits of his or her service as a high school athletic administrator, district athletic administrator and/or state athletic administrator. The nominee's character also will receive consideration. To be eligible for nomination as an administrator, the individual must have served as a high school administrator for a minimum of 20 years or as a high school administrator and coach for a minimum of 15 years, of which at least 10 years must have been as an administrator.
- A **coach** will be considered primarily for his or her achievements in senior high school coaching. Secondary consideration will be given to the nominee's achievements as a collegiate or professional coach. The nominee's character both in high school and other levels also will receive primary consideration. To be eligible for nomination as a coach, the individual must have served as a high school coach for a minimum of 20 years.
- A contributor is an individual who has made contributions to high school athletics in some capacity other than those
  previously mentioned, including such areas as sports media, sports medicine, sports official, sports announcer or
  supporter. A nominee will be considered primarily on the merits of his or her contributions to high school athletics
  and must have been involved in high school athletics for a minimum of 20 years. The nominee's character also will
  receive consideration.

All nominees will be judged on their significant and/or long-term contributions to high school athletics. While many have served their schools or areas over a long and distinguished career, their accomplishments must have been worthy of district-wide recognition for them to be considered. Longevity, without meaningful statewide impact, does not constitute appropriate credentials for Hall of Fame consideration. The Hall of Fame Committee may consider a nominee's total record of contribution to high school athletics in determining eligibility for candidacy and not just his/her record of service in the category in which the nomination is made. The Committee also may waive the minimum years of service requirement when exceptional circumstances such as injury, illness, or death have prevented an otherwise worthy candidate from meeting the requirement.
